Government of India and has a reputation and good will for the quality of services providing in Various segments for several years.

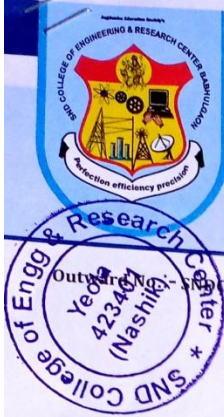

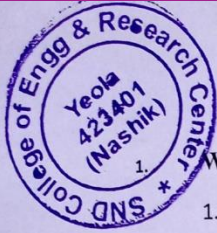
iii) That both party has agreed to the Terms and Conditions Contained in This Agreement.

1. **WARRANTY :**

- 1.1 The Meera networks will be responsible for comprehensive maintenance for entire warranty period. Warranty period will start after acceptance of installation & testing of complete connectivity.

2. **CONTRACT TERMS :**

- 2.1 To provide 300 Mbps (1:1), of Internet connectivity Leased Line at Institute and minimum 2 Public IP addresses including Reverse Lookups configured at these IP's. If required it will be increased to 4 IP's in future.
- 2.2 Committed Access Rate (Throughput) of 98 % or more of Dedicated Internet Bandwidth at fiber termination point.
- 2.3 Latency: Less than 50 ms from Google DNS to termination point.
- 2.4 Maintenance support service (24 hours and 7 days a week) for Bandwidth and Wi-Fi Equipment's.
- 2.5 Bandwidth Available for Usage: 300 Mbps. backup internet connectivity will be available at institute with 100/200 Mbps min speed during the failure of main internet Link.
- 2.6 Rate for the bandwidth will be 200/1 Mbps (Inclusive of All Taxes)
- 2.7 Service Period: Contract Period will be of minimum 2 Year starting from 01/01/2022.

3. **BILLING DETAILS:**

- Billing Cycle Quarterly and advance only.
- Payment: It shall be the responsibility of customer to make the payment within 10 days from the submission of bills.




4. Internet Utilization Report: Monthly Bandwidth utilization report can be provided if required.
5. for any change of regarding contract /internet line /rates of internet line need to be informed 30 day before by both parties .
6. Delivery of services shall be in 4-6 weeks from the date of receipt of Purchase Order along with.
7. This proposal is valid for a period of 30 days from the date of the proposal
